## **SAFETY AND LOGISTICAL INFORMATION**

Outdoor Connections Kids Holiday Programs offer children the opportunity to play, create and explore in the natural environment. To allow children maximum freedom there are a number of safety protocols that are established. Following the code of conduct makes for a day of enjoyment, engagement and fun. Anyone not adhering to this code will not be permitted to remain in the program. NO refunds will be available under this situation, for days missed. This is for everyone's safety, well-being and enjoyment.

### **CODE OF CONDUCT**

1. Children will not be allowed in the water past their knees during the programs under any circumstances.
2. Children must remain in the area designated by educator and must obey all instructions given. Boundaries are established for each location and children are informed of these.
3. Children wear easily identifiable safety vests and these must remain on at all times.
4. No child will be allowed to work outside during high wind/and or heavy rain events. The educators will check weather updates and will decide on where to work before sessions commence. In event of an extreme weather event parent/ carers will be contacted by 7am on the morning of the program. In the case where an extreme weather pattern forms during the day parents/ carers will be contacted to either collect their children or to be informed of the safety of their children.
5. No child will work on rock platforms during high tide – this will be checked daily and suitable working areas found. No-one is to work or walk near the edges of rock platforms – working areas on rock platforms will be clearly agreed and designated.
6. The organiser and adult tutors will provide supervision, undertake risk assessments for activities and make every attempt to minimise risks to all in the group, the organiser has current First Aid Certificate as well as current Working with Children Check.
7. The children are taught a range of techniques for encountering snakes, spiders and other environmental hazards. The children must practice and adhere to these for their own safety.
8. Children are to bring their own raincoat, hat, closed footwear such as sneakers or boots and to come already wearing sunscreen. Additional sunscreen is provided by the educators, parents/ guardians please provide your child with their own if they have allergies.
9. Children in the programs are encouraged to use sticks and other environmental materials in the programs. They are to adhere to the routines set in place by the educators when using these. When near trees the children are allowed to climb to a height of 80cm, which represents a height that does not require “sofffall” in established playgrounds.
10. Children are permitted to use the toilets at the places we use for activities. However, there will be times where we are a distance away from them and an emergency toileting may be needed. To lessen these incidents, all children are asked to go to the toilet before arrival and when instructed by the educators to go to the toilet when the group is taken to them at break time.
